3. Product Description

Graham & Brown offers a wide range of premium paints, including:

- Ultra Matt Resistant Paint
- Emulsions
- Eggshell Interior
- Eggshell Exterior
- Gloss

These paints are designed to provide high-quality finishes with durability and aesthetic appeal for both residential and commercial applications.

4. Safety Warnings

General Safety Warnings:

- **Fire Risk:** Paint products may be flammable when wet. Keep away from open flames or heat sources during application and drying.
- Chemical Exposure: Paint products may contain chemicals that could cause irritation or allergic reactions. Always follow safety instructions and wear protective gear (e.g., gloves, masks, and goggles) when handling paints.

5. Usage Instructions

Ultra Matt Resistant Paint

- **Application:** Stir the paint well before use. Apply with a brush or roller for the best finish. For optimal results, apply two coats of paint.
- **Drying Time:** Allow 2-4 hours for the first coat to dry before applying the second coat. Drying time may vary depending on temperature and humidity.
- Cleaning: Clean tools immediately after use with water.
- **Maintenance:** Clean the painted surface with a soft cloth or sponge and mild soap. Avoid using abrasive cleaners.

Emulsions

- **Surface Preparation:** Ensure the surface is clean, dry, and free of grease. Sand any rough surfaces and use a primer if needed.
- **Application:** Stir the paint thoroughly. Apply using a brush, roller, or spray for even coverage. Two coats are recommended for full coverage and durability.
- **Drying Time:** The first coat should be touch-dry within 1-2 hours. Allow 2-4 hours between coats for optimal results.

- Cleaning: Wash tools with warm, soapy water immediately after use.
- **Touch-ups:** For minor touch-ups, lightly sand the surface before repainting to ensure a smooth, seamless finish.

Eggshell Interior

- **Surface Preparation:** Clean and sand the surface to ensure a smooth, even finish. Fill holes and cracks before painting.
- Application: Stir the paint well. Apply one or two coats using a brush or roller.
- **Drying Time:** Allow 2-4 hours for drying between coats. Full curing may take up to 7 days.
- Cleaning: Clean painted surfaces with a damp cloth or sponge. Use a mild detergent solution. Avoid abrasive cleaners that could damage the finish.
- **Touch-ups:** For touch-ups, lightly sand the area before applying another coat for a seamless blend.

Eggshell Exterior

- **Surface Preparation:** Ensure the surface is clean, dry, and free from moss, algae, or mildew. If necessary, use a suitable exterior primer before applying paint.
- **Application:** Stir the paint thoroughly before use. Apply using a brush, roller, or spray gun for even coverage. Two coats are recommended for full protection.
- **Drying Time:** Allow 4-6 hours for drying between coats. Ensure the temperature is above 10°C (50°F) during application for optimal results.
- Cleaning: Clean tools immediately after use with water.
- **Maintenance:** For cleaning, use a mild soap solution with water. Avoid using harsh chemicals or abrasive materials to preserve the finish.

Gloss

- **Surface Preparation:** Clean and sand the surface to remove any rough patches. If required, use a suitable primer for a smooth finish.
- **Application:** Stir the paint well before use. Apply with a brush, roller, or spray, ensuring smooth and even coverage. Gloss finishes may require multiple coats (2-3) for the best results.
- **Drying Time:** Allow the first coat to dry for 4-6 hours before applying a second coat. Ensure good ventilation to help with drying.

- Cleaning: Clean tools with water.
- **Maintenance:** To clean, wipe painted surfaces with a soft cloth and mild soap solution. Avoid using abrasive materials, as they can damage the gloss finish.

- **Paint Containers:** Dispose of empty paint containers according to local recycling regulations. Ensure the containers are clean and free from leftover paint before disposal.
